IMPORTANT NOTICE

Date

The purpose of this notice is to inform you that on December 31st, 2025, Sunstone Water, LLC dba Hiland Water Corp. (“Sunstone Water”), Salmon Valley Water Company, Lakeshore Water Company, LLC, Seavey Loop Water Company, LLC, and South Coast Water Company, LLC, submitted a joint application to request authorization to merge into Sunstone Water pursuant to ORS 757.480(1)(c). The application involves 26 water systems (listed at right.) Twenty-two of the systems are currently part of Sunstone Water. The additional systems are Lakeshore Water, Seavey Loop Water, South Coast Water, and Salmon Valley Water. If the application is approved all these systems will merge into Sunstone Water.

All the water systems and utilities listed in this notice are subsidiaries of NW Natural Water and are already jointly operated and managed. Approval of the proposed merger would streamline the corporate and organizational structure governing these water systems without adversely affecting their day-to-day operations or customer rates. No service interruptions are anticipated because of the proposed merger. Over time, the proposed merger is expected to benefit customers by reducing administrative and regulatory complexity for NW Natural Water’s Oregon operations.

Sunstone has filed a rate case requesting revisions to the rates of the above listed systems in a different docket (UW-209) for which separate notice was provided.

The proposed closing date and effective date of the merger transaction is December 1, 2026.

The property transaction being proposed by the water utility is under review by the Public Utility Commission of Oregon.
